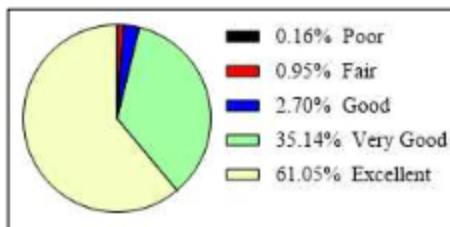


Fig 1: Content of Curriculum

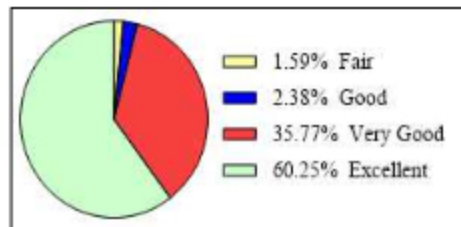


Fig 2: Usefulness of the Course

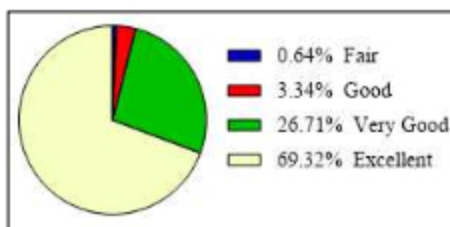


Fig 3: Textual Reading Material Availability

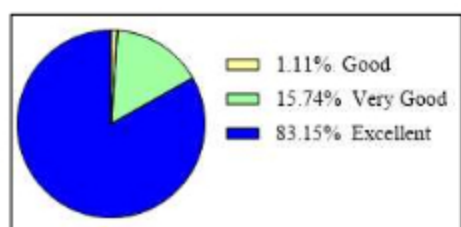


Fig 4: Relevance to Real Life Situations

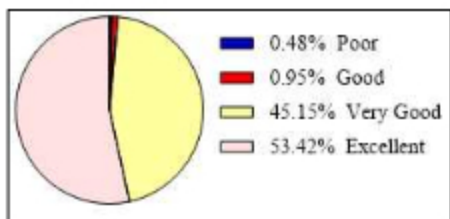


Fig 5: Potential of the course to integrate with extension and research

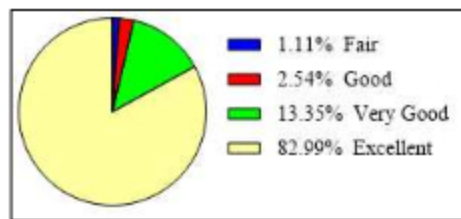
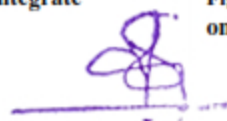


Fig 6: Information provided by teachers on outcomes of programmes

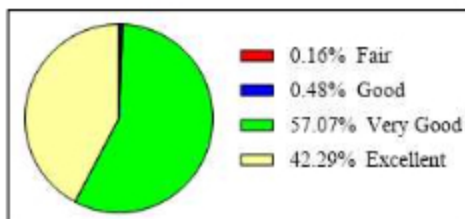


Fig 8: Conduct of Practical Classes

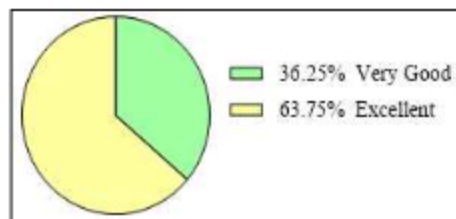


Fig 9: Internal Examination System

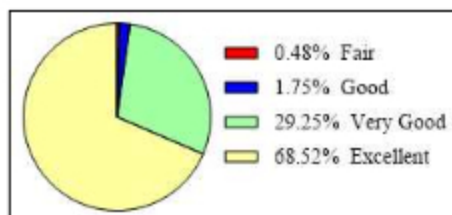


Fig 10: Overall Rating of the Programme

Summary of Student Feedback Analysis:

- ✓ It was observed that more than 90 per cent of students enrolled were highly satisfied with the course curriculum and usefulness of the course. Majority of students rated the availability of textual reading material as 'Excellent' and 'Very Good'.
- ✓ Though a vast majority of students have rated the course curriculum to be much relevant to real life situations, the potential of the course to integrate with research and extension was rated relatively lesser by student's population. Hence, a need for value added courses that could bridge the gap between curriculum and cutting-edge research was observed. IQAC has noted the lacunae in curriculum, and had proposed the same in the July 2020 IQAC meeting.
- ✓ It was observed that a minor yet significant proportion of students were unsatisfied with information provided by teachers on program outcomes.
- ✓ More than 90% of students were highly satisfied with conduct of practical classes and internal evaluation system of the institution. The institute adopts "Gurukula system" were in periodic class tests and retests precede internal examinations.
- ✓ Above Ninety-five per cent students are highly satisfied with the overall course content.
